

**North Yorkshire Police and Crime Panel****6 February 2018****Work Programme****1 Purpose of Report**

**2 Background**

- 2.2 A work programme will enable the Panel to plan and focus on how it will effectively support and provide challenge to the Commissioner. The Panel and OPCC will liaise to ensure that the Panel's work programme achieves this through timely and appropriate consideration of items.
- 2.3 The schedule provided at Appendix A therefore takes into account any developments since the last Panel meeting in relation to the timing of other review or scrutiny processes, for example via the NYP Public Accountability Meetings. It also reflects any matters which the Chair or Vice Chairs believe should be reviewed at some point during the year.
- 2.4 Members are invited to consider whether there are any items which need to be included within the forward work programme.
- 2.4 Members are also asked to note that due to notification of possible clashes with other meetings, and to enable more time for preparation of the Panel's statutory precept report, the previously agreed date of 7<sup>th</sup> February 2019 has now been moved back slightly to **Monday 4<sup>th</sup> February 2019** at 10:30am.
