## 163. Schools Condition Capital Programme - 2018/19

Considered –

A report of the Corporate Director - Children and Young People's Service seeking Executive approval for the Schools Condition Capital Programme, including the Voluntary Aided Capital Maintenance Programme, for 2018/19.

County Councillor Patrick Mulligan presented the report outlining the following:-

- ◆ The total potential capital funding available to North Yorkshire County Council for the Schools Condition Capital Programme was £12,884,960.
- ◆ The total proposed investment, as detailed in Appendix A to the report, was £10.272m.
- ◆ This provided a general contingency of £2,014,848 and an unallocated Healthy Pupils Capital Fund of £598,112.
- ◆ Details were highlighted of the additional funding provided by the Department for Education for the financial years 2018/19 to 2020/21 for pupils with education, health and care (EHC) plans in mainstreams and special schools. The total allocation for North Yorkshire was £500k.
- ◆ It was highlighted that academies would receive funding for condition related investment and evolved capital direct from the Education and Skills Funding Agency (ESFA).
- ◆ The County Council's key priorities, reflected in the 2018/19 Capital Programme were highlighted as follows:-
  - providing new school places in areas of growth
  - supporting school improvement through collaboration between schools and the restructuring of educational provision
  - meeting key local service priorities or statutory service obligations
  - enabling savings or efficiencies to be made in the use of property
  - ensuring compliance with statutory and regulatory requirements
  - maintaining the condition of the school estate to ensure buildings continue to be safe, warm, weather-tight and fit for their purpose.

- ◆ The proposed projects to be implemented in relation to those priorities were provided in the confidential Appendices.

**Resolved –**

- (i) That the proposed Schools Capital Programme for 2018/19, as summarised in Appendix A to the report, be approved;
- (ii) That the list of strategic priority schemes, as set out in Appendix B to the report, be approved;
- (iii) That the planned Capital Maintenance Programme, as set out in Appendix C to the report, be approved;
- (iv) That the Voluntary Aided Capital Programme, as set out in Appendix D to the report, be approved; and
- (v) That the approach for dealing with any schools which convert following the approval of the programme, as laid out in paragraph 3.3 of the report, be agreed.
