- 1.1 To invite the Sub-Committee to approve any recommendations received from County Councillors Bill Hault, Heather Garnett and Cliff Trotter in respect of the following applications which were approved at the Sub-Committee's last meeting but are now referred back for possible further contributions.

2.0 BACKGROUND

- 2.1 The Area Committee, on 10 March 2011, invited Members to recommend contributions from their respective allocations to fund seven applications approved by the Grants Sub-Committee on 18 February 2011. Several such contributions were recommended and approved at the Area Committee meeting on 10 March.
- 2.2 The Area Committee also agreed to refer each of the seven applications to today's meeting of the Grants Sub-Committee to give particular Members opportunity to recommend further contributions, from their allocations, for formal approval at today's meeting. Those Members wished to be aware of other applications submitted to today's meeting of the Grants Sub-Committee before committing their support to the seven applications brought before the Area Committee on 10 March.

3.0 APPROVED APPLICATIONS REFERRED FOR FURTHER CONTRIBUTIONS

- 3.1 Details of the seven applications now referred back to today's Sub-Committee meeting are set out below. (The applications were circulated with the last Agenda papers for the Area Committee and Grants Sub-Committee meetings and therefore have not been replicated again in this report. However, copies are available on request.)
- 3.2 The following table also shows the names of the Members who indicated, on 10 March, that they may wish to recommend further contributions. It also states the maximum amount, which should be approved, of any further contributions in order that the total grant from the Area Committee Budget does not exceed the amount requested from the applicant.
- 3.3 The Area Committee noted that only those County Councillors listed in the following table may wish to recommend further contributions from their respective allocations towards these applications.
